Kit# 051201702 contains 2 x Part# 0512207 and 2 x Part# 0512107. Gears include 5 bolts and 5 washers. Check part numbers match

numbers engraved on gears. If part numbers or quantity of parts don't match stop and call dealer you purchased from or call our tech line.

- Notice: These instructions are not a replacement for factory manual; factory specified tools maybe required for removal of original parts.
- Open hood then loosen & remove upper timing belt cover to access cam gears.
- Make sure crank is lined up perfectly with TDC mark, via timing mark on crank pulley and marks on timing cover.
- Remove any components which are in way of lower timing cover belt cover and then remove lower cover.
- Loosen cam gear bolts; a bar can be inserted into gears to hold from turning. Make sure crank and cam gears do not move because TDC position must be maintained perfectly throughout installation process.
- Loosen timing belt tensioner then remove timing belt and cam gears, make sure cams do not turn and are still in TDC position.
- Make sure cam snout edges have no burrs, if none are present gears will slip on easily and seat properly. <u>Don't force gears onto cams, as damage</u> <u>to both will occur voiding warranty.</u> If gear is tight clean snout with emery cloth until gears slide on.
- Install cam gears; lightly coat inner bore and rear surface of gears with anti-seize compound and tighten cam gear bolts (see torque specification below).
- Set timing belt tensioner as necessary following factory manuals specified procedure and re-install remaining components in reverse order.
- Cam gear setting of 2-3 retard on exhaust cam gives best performance results. This setting offers the most improvement throughout power band. Fine
- tuning adjustments should be done in ½ to 1 degree increments until desired performance is achieved. We highly recommend fine tuning of adjustable cam gears on a chassis dyno. Additional mods may require re-tuning of cam gears.
